About this notice

The Friends of Barnes Common take your privacy seriously and are committed to protecting your personal information. This privacy notice explains how we handle (i.e. collect, store, use, update, share and ultimately destroy) your personal data and your rights in relation to the personal data we hold.

Who are we?

We are the Friends of Barnes Common (FoBC), a not for profit charity. FoBC acts as a data controller, which means we decide how your personal data is handled and for what purposes. Data controllers are registered with the UK Information Commissioner's Office.

Personal data – what is it?

Personal data is information about a living individual who can be identified from that data; either from the data alone or with any other information already in, or likely to come into, our possession. The handling of personal data is governed by the General Data Protection Regulation (the 'GDPR').

How do we care for your personal data?

We comply with our obligations under the GDPR by:

- keeping personal data up-to-date;
- storing and destroying it securely;
- not collecting or retaining excessive amounts of data
- protecting personal data from loss, misuse and unauthorised access and disclosure.

What do we use your personal data for?

We will use your personal data such as your name, email address and telephone number for the following purposes:

- To keep you informed about FoBC activities
- To maintain our own internal records such as membership and staffing.

What is the legal basis for handling your personal data?

- for the performance of contracts between FoBC and its staff;
- to comply with our legal obligations e.g. charity or company law
- for the purposes of our legitimate interests (e.g. maintaining accurate membership records).
- where you have given a separate consent for receiving any newsletter information (however, you can withdraw your consent at any time should you wish).
- where we ask you for any medical data, you give explicit consent and this is recorded.

Sharing your personal data

We will not release your data to anyone outside the Friends of Barnes Common, unless you have requested us to do so, or we are required by law, e.g. in the case of crime or fraud or for the purposes of audit and accounting e.g. HMRC. We will not share your data with third parties for marketing purposes. We will not sell or rent your data to third parties.

How long do we keep your personal data?

We will securely destroy your data when we no longer have a legal basis for retaining it. Subject to any other notices that we may provide to you, we may retain your personal data for a period of one year after your membership with us has come to an end.

Your rights and personal data

Unless subject to an exemption under the GDPR, you have the following rights with respect to your personal data that we hold:

- to request a copy;
- to request that we correct it if it is found to be inaccurate or out of date;
- to request that we erase it where it is no longer necessary for us to retain it;
- to withdraw at any time your consent to us using it where the basis for its use is your consent;
- where there is a dispute in relation to the accuracy or use of your personal data, to request that a restriction is placed on its further use;
- to object to the handling of personal data, where processing is based on our legitimate interests;
- to lodge a complaint with the Information Commissioners Office.

Further uses of your personal data

If we wish to use your personal data for a new purpose, not covered by this Privacy Notice, then we will provide you with a new notice prior to doing so, explaining this new use and setting out the new purpose and how the data will be used. Where necessary, we will seek your prior consent to using your data for the new purpose.
